- Dual units are strongly encouraged (but not required), especially within the body of text. Units on graphs, tables, figures, etc. are not required to be both SI & IP. Use common sense and discretion when asking a presenter to provide dual units. Refer to ASHRAE "SI Guide for HVAC&R" (link) for information on the SI units and to Section F39 "Units and Conversions" of the 2017 ASHRAE Fundamentals for IP-SI conversions
- □ References or displays of trade names, logos or products provided by an HVAC&R related commercial organization are not allowed as promotion.
- □ Pictures of equipment shall have all logos removed or covered.
- □ Building signs for manufacturers, consulting firms and other industry companies are not acceptable.
- □ Names or reference to specific software programs that is imperative for a viewer to reproduce or understand the study, can be listed ONCE and then not repeated through the remainder of the

presentation. Instead, the product may be referred to as "SOFTWARE 1", "SOFTWARE 2", etc. This pertains to free (open source) programs too.

- □ Software screen displays are not acceptable if they show the program name.
- □ Presenter shall not imply ASHRAE approves or endorses a product
- □ ASHRAE logo shall not be used without prior express permission from the society.
- Presentation shall not reference make, model or sole source of critical test instrumentation, engineering software, reagents or apparatus may be identified as a footnote, so that others may duplicate the testing. Presentation may include research, programs, policy, legislation or name of organizations, software, government agencies and government-sponsored agencies may be referenced only in order to maintain presentation clarity and relevance. Promotion or endorsement is prohibited
- □ Reference to Universities, research, government or not-for-profit organizations shall be referenced for clarification only and not endorsing the affiliation.
- □ Specific reference may be made to industry-related standards, test methods and codes. Cover Images of industry related non-manufacturer non-product specific codes, standards, and guidelines publication are allowed. Some examples include ANSI Z21.19-2002, UL 425, AHRI 1110-2006, NFPA 20-2010.
- □ Images of product specific or non-industry related Magazine, Journal, Standard or other published documents are not allowed.
- Active hyperlinks are not allowed including but not limited to websites, emails, or documents, URLs are allowed (Right click to remove the hyperlink).
 Exception: QR codes with explicit URLs are allowed, provided that all texts and images linked by are also present in the presentation, and that they comply ASHRAE Conference Presentation Policy.
- □ Be mindful of the number of slides included. Most presenters only have 10-15 minutes to present and they will likely not make it through 45 slides in that time.
- □ References made within the presentation may be done via a bibliography or footnote. If research is being presented, that research should NOT be included in the bibliography.

- 2. Slide 2: This slide needs to include the AIA Disclaimer. Please copy and paste onto this slide ASHRAE is a Registered Provider with The American Institute of Architects Continuing Education Systems. Credit earned on completion of this program will be reported to ASHRAE Records for AIA members. Certificates of Completion for non-AIA members are available on request *"This program is registered with the AIA/ASHRAE for continuing professional education. As such, it does not include content that may be deemed or construed to be an approval or endorsement by the AIA of any material of construction or any method or manner of handling, using, distributing, or dealing in any material or product.
