- Once the change proposal is submitted you will receive an automated email from CMPAcknowledgement@ashrae.org indicating that the CMP has been submitted for Staff review. If information is incomplete or needs change then you will receive an email directly from the appropriate staff for correction. If the CMP is in order you will receive an additional email indicating that the CMP has been submitted to the cognizant PC for review.
- At anytime during the process you can log in to the OSR and see your proposals by clicking on My Proposals under the Continuous Maintenance tab. The status of the proposal will be shown under Proposal Status.
