#### 2. Adoption of the Agenda

The agenda was adopted as written and the ASHRAE Values Statement, Code of Ethics, Core Values, Diversity Statement, and GTIC purpose and scope were reviewed.

### **3.** Approval of Minutes

The minutes of the 21 May 2024 virtual meeting were reviewed. The minutes were approved by consensus as presented.

## 4. Region and Chapters Interactions Subcommittee (RCIS) Report

The RCIS Report was presented by RCIS Chair, Eleazar Rivera. RCIS continues to spread awareness of GTIC to a wider audience. Eleazar attended an Expo Frio Calor in Chile, national event with Region 8 and Region 12. Chile has recently published a modified adaptation of Standard 62.1 with contribution from local ASHRAE chapter members. A roadmap will be developed to understand how and what is the most efficient way that each "natural" region interacts and what efforts will be more valuable regarding each committee in certain chapters. There is a plan to work with staff to spread awareness of the purpose and existence of GTIC by posts on social media. Results of the survey were presented and graphics will need to be generated from the data gathered for visual representation. Olu suggested to distribute the current results to Chapter and Region leaders. The results and survey can be communicated out of GAC to the boarder membership. Eleazar to be upcoming Chair of GAC. Olu Soluade thanked RCIS and Eleazar for their participation and commitment to GTIC.

## 5. Technical Committees Interactions Subcommittee (TCIS) Report

Kevin Mercer presented at the TC Chairs Breakfast alongside Steven Bushby and Drake Erbe to spread awareness and the shared accomplishments of GTIC. Steven Bushby spoke on correlation between ANSI and ISO and provided better understanding to the TCs on importance of this relationship. TAC will continue to be fully engaged in GTIC as Satheesh Kulankara will be the Vice Chair of TAC and Kevin Mercer is incoming Chair of TAC.

## 6. Project Committees Interactions Subcommittee (PCIS) Report

The last MBO in 2023-2024 is to work on the ISO/ASHRAE matrix; subclassification to identify the entities to focus development or modification is currently in progress. The matrix is a working document and will need to be communicated to out to members to gauge interest and for effective updating. Adrienne Thomle mentioned that there is an existing matrix and can provide an opportunity to update or revise standards. Doug Fick presented GTIC's existence and scope at the PC Chairs Breakfast. An MOU with GCC has been signed and approved by the Board of Directors ExCom. Relevant tasks developed from MOU will be facilitated by GTIC. Ryan Shanley mentioned that a proposal to develop a district cooling standard (related to the Empower MOU from the UAE) has been approved by PPIS and Standards Committee, and awaits Technology Council and BoD approval.

## 7. Liaison Reports

GTIC is planning to review ASHRAE's existing MOUs to explore where there could be opportunities for increasing ASHRAE's global engagement, particularly in the standards arena. Eleazar Rivera and Jacob Karson will produce the report of survey data with graphics. Survey and report to be presented beyond U.S Chapters in order to receive more responses. George Pantelidis believes that further investigation is needed by the Publications team to determine interests by country. Olu reminded the committee that GTIC exists as a conduit and can provide guidance to the Standards Committee. George has a written report from GAC (to be distributed), and continues to inform TC and PC Chairs on the purpose of GTIC. GTIC membership agreed that translations of standards can be done by volunteers rather than by ASHRAE hiring of outside consultants. A question was raised about a pilot use of AI for standards translations; Mark Owen clarified that AI translations have not been done and translation. There are seven guides either published or under development by the CEBD/TFBD and chapters/regions are inquiring

about adaptation/adoption of decarbonization-related standards. A request for adaption can be submitted to Mark Owen or Stephanie Reiniche on ASHRAE staff. It is not yet determined for this process if there is a cost associated with submitting such a request. Kevin Mercer will present training on this process t the TC Chairs Breakfast during the 2025 Winter Conference in Orlando. A question was raised as to whether or not GTIC will prioritize adaption of standards; it was reiterated that while GTIC can be involved, its role is to act as a conduit and facilitate, rather than actively manage or prioritize specific tasks. Jacob Karson mentioned the PPIB documentation tool which is utilized as a way to communicate standards with less technical language.

### 8. Status of MBOs

GTIC reviewed the MBOs as shown in <u>Attachment D</u>. Ashish Rakheja presented plans and new MBOs for 2024-2025. <u>Attachment E</u>.

#### 9. International/Region Updates

Drake Erbe reported that the European Union Buildings Environmental Declaration is final as of 5 May 2024. There are no mandates, although some former EU Energy Mandates are still in force, such as EcoDesign for units. This will require equal access to all buildings' data, which implies system modeling. This will require high consideration of 8760 hour information and data and reporting on all emissions. Although not codified, any modeling or calculations will have to use the overarching standards of the ISO 52000 series or equivalent to evaluate the building performance. Buildings will have a building label subject to independent auditing. There will be a workshop during the ISO/TC 163/205 meetings in Paris in October 2024 that will include a panel with representation from IEA, ASHRAE, members of COP28, and others. The workshop title is "Standardization leading to Harmonization and Decarbonization."
