#### CALL TO ORDER, WELCOME AND ROLL CALL

The agenda was accepted as written.

#### APPROVAL OF MINUTES FROM OCTOBER 30, 2019 MEETING

**MOTION:** To approve the minutes of October 30, 2019 as written.

Ms. Yates reported that have been three Action Items, and one is still open. Chair Chakroun ordered that it should be marked as complete, because it is an ongoing task. (See Attachment A.)

#### REPORT FROM ASHRAE GOVERNMENT AFFAIRS OFFICE

Ms. Yates from the Government Affairs Office reviewed a report of activity from the past 6 months, which highlighted the great work of ASHRAE members, including 34 articles in the Government Affairs Update, an increased number of Government Outreach Days, and meetings in DC by the ASHRAE Senior Officers. Ms. Yates also discussed policy trends and upcoming policy issues of interest to ASHRAE. (See Attachment B.)

#### YEAR-END SUBCOMMITTEE REPORTS AND MBO STATUS REPORTS

The mid-year subcommittee reports were presented, along with progress made on MBOs assigned to each subcommittee. (See Attachment C.)

Executive Subcommittee (Mr. Chakroun)

**MBO** #4: Build bridges with intergovernmental organizations to introduce them to ASHRAE as the leading source for technical HVACR information.

Mr. Chakroun reported that ASHRAE is working closely with UNEP and looking for more international organizations to work with.



**MBO** #5: Provide support to chapters outside North America utilizing both the Government Affairs Office in Washington and the Global Training Center in Dubai and the ASHRAE staff office in Europe.

Mr. Chakroun reported that Steve Comstock is working on various government outreach activities, and has been sharing information with GAC.

#### Chapter Letters Concerning Public Policy, Legislation, and Regulations

**MOTION:** That the Manual for Chapter Operations, Section 2.5 "Government Affairs Committee" be revised as shown in the Attachment D to provide clarity for ASHRAE Chapters in communicating with a governmental body.

#### MOTION PASSED: APPROVED BY VOICE VOTE (CNV).

Policy and Programs Subcommittee (Mr. Gill)

**MBO** #3: Identify areas for which ASHRAE can lead proactively in the future.

Mr. Gill reported that refrigerants, resiliency, and targeting jurisdictions that have 2030/2050 climate goals and other energy efficiency goals are areas where ASHRAE can lead proactively. These are in-line with the ASHRAE strategic plan.

Mr. Gill also reported that the subcommittee approved the approach for moving forward on PPIBs, and approved two of them.

**MOTION:** That the PPIBs with the titles below and shown in Attachment E be approved and submitted to the Document Review Subcommittee for review.

Consensus Standards: Expert Solutions to Meet National Needs Refrigerants and Their Responsible Use

#### POLICY AND PROGRAMS SUBCOMMITTEE REPORT

The Policy and Programs Subcommittee has met two times in SY 19-20. The first meeting took place on January 8, 2020 and the second meeting took place at ASHRAE's Winter Meeting in Orlando, Florida. The subcommittee expects to be a lot more active going forward.

The Subcommittee has two MBOs assign to it for this Society Year:

- MBO #3: Identify areas for which ASHRAE can lead proactively in the future.
   The Subcommittee has identified three areas in which ASHRAE can lead proactively in the future. They include:
  - o Resilience
  - Next generation refrigerants and low-GWP refrigerants
  - Targeting jurisdictions that have 2030/2050 climate goals, and other energy efficiency goals (such as building benchmarking requirements)
- MBO #7: Develop implementation plan for promoting ASHRAE standards for use in the
  residential market. For the international audience, promote the customized version of 90.2 to
  be used in different part of the world. Examples: Kuwait and Saudi Arabia.
  - This MBO is also assigned to the Global Affairs Subcommittee. At this time, they have not made any recommendations on additional resources that are needed.

The PPIBs have also been discussed and reviewed. Subcommittee members made recommendations at the Winter Meeting.

Additionally, the Policy and Programs Subcommittee must review the PAOE criteria. As part of this effort, the Policy and Programs Subcommittee voted to change GA8 to include a requirement for reporting government outreach. GAC's Policy and Programs Subcommittee also reviewed the proposed PAOE recommendations from President-Elect Chuck Gulledge during their meeting on January 8, 2020. The subcommittee agreed that several of the PAOEs mentioned in the recommendations were not duplicates and decided to make no modifications based on that list.



# Member Mobilization Subcommittee Report

### Member Mobilization Subcommittee SY 19-20

- This is the 5<sup>th</sup> meeting of the Member Mobilization Subcommittee this Society year.
- The Subcommittee is primarily tasked with responding to government officials on public policy matters, identifying opportunities for action alerts, reporting on ongoing public policy projects, recommending areas for improvement on public policy engagement, and recognizing emerging public policy issues.



MBO	Status
MBO #1: Contact at least one government entity and collaborate with at least one aligned organization in each region. (with Global Affairs)	Mr. Collerman and Mr. Conghos are developing a list of organizations by region. They are working in conjunction with the Global Affairs subcommittee to coordinate efforts. Currently, about half the regions have held events or planned.

### **MBO**

MBO #2: Develop more efficient processes to enable sharing of resources and information with ASHRAE grassroots members to support the Public Policy Priorities and inform government officials in every region across the globe.

#### Status

Mr. William, Mr. Jesson, Mr. Smith, and Mr. Collerman have worked with ASHRAE staff to update the all of the GAC webpages. Several updates have been coordinated with the marketing group, but waiting on a few more edits to get all the changes pushed to the website at one time. The pages will be more consistent, concise and navigable, making it easier to ASHRAE members and government officials to find the resources that they need.

MBO #6: Develop and implement programs to promote awareness and use of Building EQ (in cooperation with the Building EQ Committee.	A Survey went out in August to RVCs looking for feedback related to Building EQ adoption. Six RVCs responded to the survey.  The survey highlighted possible areas for outreach, as well as areas to assess for improvements. A common concern was that Building EQ is not well known and that states and localities are using EnergySTAR, because governments know it and it is free.  As a result of the survey, Mr. Townsend and Mr. Laisure-Pool are working with the Building EQ Committee to develop Building EQ materials tailored for government officials. These materials are expected to assist RVCs with the education gap. The first draft of a quick fact sheet has been created and is being reviewed by GAC.



Mr. Smith and Mr. Williams spearheaded the website overhaul and provided recommendations for ways to streamline the site.  Mr. Smith and Mr. Williams are currently in the process of updating materials related to Developing a Successful Day on the Hill, which is anticipated to be completed by the end of the calendar year.  Additionally, Mr. Smith and Mr. Williams have begun brainstorming what resources would be most helpful to assist ASHRAE members as they film footage from their Days on the Hill, and FAQs for Chapters about what pictures and interviews to consider including. We are reaching out to marketing to get specific direction on video footage needed to produce an updated promotional video this year.

# Global Affairs Subcommittee – Responsibilities

- 1.Developing strategies to promote and grow activities that reflect the global nature of the Society;
- 2. Identifying best practices for government outreach outside of the U.S. so that chapters can successfully promote the Public Policy Priorities internationally and build connections with government officials, institutions, non-governmental organizations, and private parties;
- 3. Monitor key public policy needs of government officials and policy makers internationally concerning the built environment, and make recommendations for responding to these issues;
- 4. Provide regular reports to the GAC on global outreach activities.

### **GASC MBOs**

MBO #1 – Contact at least one government entity and collaborate with at least one aligned organization in each region to help in successful government outreach.

- Online reporting form has been created to make government outreach easier to record.
- Outreach outside North America is now being tracked with Federal and State DOTH.
- 7 events/meetings with government officials has been reported and 2 more are scheduled.



### **GASC MBOs**

MBO #7 — Develop implementation plan for promoting ASHRAE standards for use in the residential market. For the international audience, promote the *customized* version of 90.2 to be used in different part of the world. Examples: Kuwait and Saudi Arabia.

- Gian Modgil has been promoting a customize version of 90.2 and the Mumbai Chapter has been promoting a customized version of 188.
- Still working to identify additional material that would be helpful for this type of outreach.



### **GASC MBOs**

MBO #8 – Expand Government Outreach Days/DOTH including development of new training materials to include documents, videos and case studies, and extend to Federal Congressional outreach. Work on model Outreach day including materials specifically targeting outside North America Chapters.

#### **Possible MOTION ON CHAPTER COMMUNICATIONS WITH GOVERNMENT BODIES**

**MOTION:** That the Manual for Chapter Operations be revised as shown below to provide clarity for ASHRAE Chapters in communicating with a governmental body.

#### 2.5 Government Affairs Committee

- If approved by the BOG, assisting a governmental body in writing or developing a regulation, a code, an ordinance or law, <u>including through issuing a letter or providing written or verbal</u> <u>testimony concerning such matter</u>, or participating in an advisory group to such a body, provided such activity:
  - i. Does not conflict with Society or chapter bylaws, or Society-approved documents or publications;
  - ii. Involves technical or method-of enforcement aspects only, and not support of a political party or candidate;
  - iii. Does not jeopardize the chapter's tax status (e.g., 501(c)(3) tax status in the United States) or cause the chapter or a chapter member to exceed local, provincial or state limits regarding registration as a "lobbyist" or "lobbying organization;"
  - iv. Chapter shall review the state legislation prior to engage in any lobbying effort, time expander or in-kind gifts. National Conference of State Legislatures web site reference links to state's legislative ethics and lobbying laws: http://www.ncsl.org/research/ethics/50- state-legislative-ethics-and-lobbying-laws.aspx#al; Any Federal Government lobbying activities must be coordinated strictly through the ASHRAE Government Affairs Office; this is to ensure proper preservation of the IRS 501(c)(3) status.

See Appendix 2N for the list of links for each U.S. state.

- v. Chapters to contact the ASHRAE Government Affairs Office staff liaison and the appropriate GAC Regional Vice Chair (RVC) prior to engaging in any lobbying activities in order to mitigate any potential issues that might arise. This is to conform with the "Chapter cannot speak for Society" policy. In addition, staff and/or the RVC may recommend other chapters join in sending a letter or providing testimony, and/or issue a letter or provide testimony from ASHRAE Society.
- vi. Does not conflict with any existing Memorandum of Understanding or contractual obligation between ASHRAE and another code or standards writing organization; and
- vii. The member does not request any travel or transportation reimbursement (as defined by the ASHRAE Travel Policy), nor any reimbursement for time away from their regular employment, for the activity.
- Note: All responses and recommendations to governmental advisory boards or agencies shall promote ASHRAE's mission to advance the arts and sciences of heating, refrigerating, air conditioning and ventilating, and the allied arts and sciences, for the

benefit of the general public, and should, wherever feasible, be based upon current Society Board-approved documents or publications (e.g., Position Documents, ASHRAE Standards, ASHRAE Handbooks, etc.). Where such policy information is not clear, readily available, or applicable to the Chapter's climate or jurisdiction, the Chapter GAC chair shall request input from the Government Affairs Committee and the ASHRAE Government Affairs Office staff liaison.

#### **BACKGROUND:**

Government officials and bodies, especially those serving in an elected position, will often pay more attention to communication provided by, and sent from those individuals and/or organizations who are constituents and/or local residents. For this reason, letters sent by ASHRAE Chapters can be a more powerful communication tool. The Manual for Chapter Operations<sup>1</sup> includes a section on Government-Related Chapter Communications; however, it does not provide any specificity with respect to writing letters to governmental bodies, or providing testimony on policy, legislative, or regulatory matters.

#### CONSENSUS STANDARDS: EXPERT SOLUTIONS TO MEET GLOBAL NEEDS

#### THE ISSUE

Voluntary consensus standards developed by private organizations are essential for a sound global economy and to facilitate global commerce. Standards foster building technology innovation by providing a transparent baseline and needed metrics for assessing how that technology can impact building design and performance. They are necessary for comparing technologies in the expanding global marketplace. U.S. Federal policy recognizes the value of voluntary consensus standards by requiring their use in regulations when consistent with agency policy and appropriate for agency purposes.<sup>1</sup>

Voluntary consensus standards are developed through the participation of any and all interested and affected stakeholders including manufacturers, users, advocacy organizations and representatives of government and academia. Standards accreditors such as the American National Standards Institute (ANSI), the International Organization for Standardization (ISO) and the International Electrotechnical Commission (IEC) follow several principles such as including consensus, openness, balance, transparency and due process, and ensure that designated standards development organizations follow these principles and processes.

Copyright protection of voluntary consensus standards is critical to the continuation of the development and maintenance of standards. Without copyright protection for standards, resource-limited government agencies would have to undertake the difficult and expensive task of replicating the system of standards development organizations, or the standards-development process would be put into the hands of regulated parties with uncertain outcomes.

#### **ASHRAE's ROLE**

ASHRAE develops and publishes robust standards; many of which are adopted into building codes. ASHRAE standards establish recommended practice in the areas of indoor air quality, energy conservation and management, building water systems, high-performance buildings and others. ASHRAE's standard development process is rigorous, and it is one of only six standards-developing organizations in the U.S. that can self-certify that its standards have followed ANSI's procedures. ASHRAE also serves on U.S. Technical Advisory Groups (TAGS) for ISO Committees and in the role of international secretariat for ISO Technical Committees to help ensure that ASHRAE views are represented. These standards are supported by technical committees that develop publications and educational materials to assist in the application of ASHRAE standards.

### **ASHRAE's VIEW**

Use of voluntary consensus standards at all levels of government are a benefit to society. For this reason:

- Government entities should continue to support voluntary consensus standards in laws and regulations, which will protect public health and safety, improve commerce and save taxpayers money.
- Agencies should work with standards developers and industry to identify situations where societal interests could be addressed through the use of voluntary consensus standards and work together for common solutions.
- Governments should continue to foster and support the unique character and strengths of the
  public-private partnership in standards development as they pursue trade and other
  international agreements, regulatory harmonization and legislative and regulatory
  approaches.
- Governments should support policies, both domestically and internationally, which ensure the continued ownership and control of the copyrights and trademarks of standards developers.
- Government agencies should increase participation in the development of voluntary consensus standards, by encouraging government experts to participate, through release time and expenses incurred.



#### REFRIGERANTS AND THEIR RESPONSIBLE USE

#### THE ISSUE

ASHRAE promotes the responsible use of refrigerants during the processes of design, manufacturing, operation and servicing of systems, as well as proper management at the end of equipment life. However, choosing a refrigerant for a given HVAC&R application has become increasingly complex due to their direct and indirect environmental impacts in addition to societal implications they may have based on performance, cost-effectiveness and safety of employees and the public.

Since the implementation of the 1987 Montreal Protocol, and the Kigali Amendment to the Protocol in 2016, transitions to lower global warming potential (GWP) refrigerants are on the rise. This has led to an increase in the development and utilization of flammable refrigerant options that have low-GWP characteristics to meet targets. As a result, safety standards need to be reassessed and updated to reflect the increasing interest in flammable or mildly flammable working fluids.

#### **ASHRAE's ROLE**

With its technical expertise, ASHRAE plays a key role in guiding the choices that must be made for the management of new refrigerants due to the environmental and societal consequences posed by refrigerant management. ASHRAE contributed to the successful effort to phase out ozone depleting refrigerants, and it has a significant role in encouraging the proper and safe use of refrigerants going forward. ASHRAE develops voluntary standards and guidelines governing the application and use of all types of refrigerants. These technical requirements are being adopted into various codes and regulations.

As governments commit to using lower GWP refrigerants, ASHRAE wants to ensure the safe application of these refrigerants, including through the adoption of ASHRAE Standard 15, *Safety Standard for Refrigeration Systems*, and Standard 34, *Designation and Classification of Refrigerants*. Recent updates to these standards were made following a \$5.2 million research program, with financial contributions from DOE (\$3 million), ASHRAE (\$1.2 million) and AHRI (\$1 million), as part of an ongoing global effort to phase out the use of high-GWP refrigerants and identify appropriate climate-friendly alternatives.

### **ASHRAE's VIEW**

ASHRAE believes the selection of refrigerants and their operating systems should be based on a holistic analysis of multiple criteria. These criteria include energy efficiency and performance attributes, environmental impacts, employee and public safety and economic considerations.

To limit impacts on the environment, emissions of refrigerants should be reduced through research, education, improved design, manufacturing/construction of equipment, field commissioning, maintenance procedures, decommissioning and enforcement of applicable standards and regulations.

ASHRAE is committed to a leadership role in reducing climate change contributed to by building systems and responding to climate change experienced in the built environment. As part of this effort, ASHRAE supports the global phasedown of the production and consumption of refrigerants that are high-GWP HFCs, including through legislation, regulations, and policy.

Where possible, refrigerants should be safely recovered for reuse, recycle, reclamation or destruction during service or at the end of the life of the equipment. Refrigerant inventory and management programs should be implemented to closely track refrigerant use.

ASHRAE encourages and supports ongoing efforts to develop new refrigerants and improve the application of existing refrigerants to meet these criteria.

# Government Affairs Committee Manual of Procedures

Approved by Grassroots Government Advocacy Committee on January 11, 2019 and accepted by Members Council on January 15, 2019.

#### **Staff Liaisons**

The staff liaisons shall assist in carrying out Committee duties, including:

- 1. Generate, submit for approval to the Chair, and distribute meeting minutes within 10 business days after Committee meetings.
- 2. Distribute other supporting documents to Committee members in a timely manner.
- 3. Assist the Chair in preparation of timely, informative reports to the Members Council and the BOD.
- 4. Welcome new members appointed to this Committee and send them copies of the current Committee roster, MOP, minutes of the past Committee meetings, and other pertinent information, as applicable.
- 5. Assist the Vice Chair with generating the Committee's budget and four-year plan.
- 6. Maintain a copy of accounting records and financial statements for the Committee.
- 7. Process appropriate transportation reimbursement requests for Committee members.
- 8. Support the Committee in carrying out Strategic Plan Objectives (SPO's).
- 9. Update this Committee's MOP as directed by the Committee.
- 10. Update and process materials for this Committee's workshops at CRC's.
- 11. Assist in the preparation of materials for training incoming Committee members.
- 12. Assist the Chair in conducting training of Committee members at the Annual Meeting and the Winter Conference, and in qualifying Committee members to provide training at CRC Workshops and Chapter events.
- 13. Respond to inquiries from Chapters regarding this Committee's activities.
- 14. Assist the Communications Coordinator, the Vice Chair, and ASHRAE IT staff with maintaining a website whereby the membership of ASHRAE can readily obtain information regarding grassroots government activities in any geographical location where ASHRAE has a presence.
- 15. Provide support for this Committee's Government Affairs Awards Program, coordinate notifications, transportation to the Society Meeting, and Society notification to award winners.
- 16. Provide information and appropriate contact with government agencies in support of Committee grassroots government activities.
- 17. Provide administrative support for this Committee's programs.

- 18. Coordinate update of website per this Committee's directives.
- 19. Offer public policy updates and guidance to the Committee on:
- a. Summary of recent grassroots government activities (as informed by the Society's Public Policy Priorities).
  - b. Trends relative to such priorities at the grassroots government level.
  - c. Existing or potential collaboration with partnering policy organizations.
  - d. Summary of recent requests for input from ASHRAE's GA team, requests for ASHRAE GA action for specific issues being addressed at national, sub national, and local government levels, and the actions that were taken (or not taken) to respond to these requests.

The Chair shall appoint Committee members to each Subcommittee annually. Subcommittee members may include voting members of this Committee and individuals with specific and relevant experience needed on each Subcommittee.

The Chair of this Committee shall form Subcommittees to conduct the business of the Committee in a practical and efficient manner. As conditions change, standing Subcommittees may be dissolved. The Chair may also form ad-hoc Subcommittees as needed.

Subcommittee members are appointed for a period of one year and may be reappointed by the incoming Chair.

Standing Subcommittee membership and responsibilities are assigned as follows:

#### a. Executive

The Executive Subcommittee (ES) consists of the Chair, Vice Chair, Subcommittee Chairs, Communications Coordinator, Representative of Tech Council, Representative of Members Council, Representative of PubEd Council, Consultants and the BOD ExOs.

Responsibilities of the Executive Subcommittee shall include:

- 1. Develop the proposed yearly Public Policy Priorities for the Society.
- 2. Develop and monitor the Committee's MBOs.
- 3. Develop budgets and monitors Committee expenses.
- 4. Review and approve requests for action alerts.
  - a. Action alerts are requests to the membership to support an active issue such as pending action on a bill affecting indoor environment.
  - b. Requests for action alerts may be proposed or initiated by individuals or groups within or outside GAC.
  - c. When a request for an action alert is received, ES shall make a preliminary judgment as to whether it is necessary and supported by an approved position of the Society.
  - d. If an action alert request is deemed necessary and supported by approved positions of ASHRAE, and if ES agrees that an alert should be issued, timely concurrence from Society Executive Committee will be sought by the Coordinating Officer.

- e. If an action alert is found to lack support in approved ASHRAE positions and if ES believes an alert should be issued, the Coordinating Officer shall, in a timely manner, seek a supporting position from Society Executive Committee and report it to ES for further consideration.
- 5. Review and approve requests for input and/or support for specific issues being addressed at national, sub national, and local government levels.
  - a. Requests for input and/or support for specific issues being addressed at national, sub national, and local government levels are initiated by those outside of the GAC.
     Requests for support often are asking ASHRAE to publicly express an opinion on issues that are considered to be related to ASHRAE's interests.
  - b. Requests for input and/or support may be proposed or initiated by individuals or groups within or outside GAC or ASHRAE.
  - c. When a request for input and/or support is received, if time allows, ES shall make a preliminary judgment as to whether it is supported by an approved position of the Society.
  - d. If an input and/or support request is deemed relevant and supported by approved positions of ASHRAE, and if ES agrees that the input and/or support should be provided, timely concurrence from Society Executive Committee will be sought by the Coordinating Officer.
  - e. If a request for input and/or support is found to lack support in approved ASHRAE positions and if ES believes the input and/or support should be provided, the Coordinating Officer shall, in a timely manner, seek a supporting position from Society Executive Committee and report it to ES for further consideration.
  - f. ASHRAE GA staff should inform the GAC chair when requests are received and advise the chair as to whether or not the request aligns well with existing ASHRAE priorities and documented positions. If time allows, the chair then determines whether to bring the issue to the ES for discussion or authorize staff to address the issue directly.
  - g. For requests received by staff that do not allow time to be considered by the GAC ES and/or GAC ES chair, staff may recommend action directly of the Society Executive Committee and/or Society President. Staff should inform the GAC chair of these time-sensitive requests and recommendations, along with the action taken.

#### c. Member Mobilization

The members of the Member Mobilization Subcommittee are appointed annually by the Chair of the GAC and consist of approximately half of the RVCs on the GAC. Members of the Executive Subcommittee may, at their discretion, serve as *Ex Officio* members of the Responsive Engagement Subcommittee.

Responsibilities of the Member Mobilization Subcommittee shall include:

- Monitor and respond to public policy-related requests from government officials and nongovernmental organizations on public policy issues deemed important by the Society, including, but not limited to those issues identified in the Society's Public Policy Priorities. Refer to GAC MOP section 6.a.4 and 6.a.5.
- When deemed necessary, prepare and submit requests for action alerts or for providing input and/or support for specific issues being addressed at national, sub national, and local government levels to the Executive Subcommittee.
- 3. Provide regular reports to the GAC on the status of ongoing public policy projects. These reports shall include recommendations for improving the effectiveness of the Society's public policy operations.
- 4. Provide recommendations to the GAC on emerging issues that are not the current primary focus of the Society, but have the potential to become of greater interest and thus may warrant greater future attention.
- 5. Manage Government Affairs Awards Program.
- 6. Review and update training materials prior to Winter Meeting.

### 8. AWARDS PROGRAM

## a. Government Affairs Award

The Government Affairs Award was established to recognize an individual for outstanding effort and achievement in state, provincial, national, sub national, and local government activities in connection with technical issues related to the activities of the Society.

- Recognition is in the form of a plaque for first place winners.
- One awarded per year.
- The Government Affairs Committee makes recommendations for the award to the Honors and Awards Committee at the Winter Meeting.

#### I: GOVERNMENT AFFAIRS AWARD

The Government Affairs Award recognizes an ASHRAE member who demonstrates outstanding efforts in the national, <u>statesub-national</u>, <u>provincial</u> and/or local government on technical issues important to ASHRAE.

#### **Purpose**

The purpose of the award is to stimulate effective participation by ASHRAE members <u>and</u> recognize an individual for outstanding effort and achievement in national, state, provincial subnational, and/or local government activities in connection with technical issues related to the <u>purpose activities</u> of the Society.

Guidelines for the Government Affairs Award Presentation

Each year the Society recognizes exceptional performance by a member in the area of government activities. During the Society fiscal year, Chapters assemble support materials describing. The award submission shall include the member's a summary of the GAC program for the Society fiscal year including activities in interacting with national, state, provincial subnational and/or local governments.

A typical award application includes a standard cover page (see below), a narrative section, the Chapter's government advocacy plan, the member's government advocacy with relevant documentation, publicity, etc. The narrative section should describe the activity or activities that distinguishes the nominee, the impact of that activity or activities (be as specific as possible), the level of chapter engagement and likelihood of continued chapter engagement with the activity or activities, and any other description to support the nomination.

The length of the nomination should be approximately 3 pages, not including supporting materials.

Eligibility Requirements

An ASHRAE member of any level interacting with national, state, provincialsubnational, and/or local governments is eligible for nomination for this award. Applications-Individuals may be submitted nominated by a Chapter, or by any ASHRAE member in good standing, or may selfnominate if they are in good standing. The winner is selected from these entries. The Chair of the GAC Member Mobilization Subcommittee is responsible for organizing the Government Affairs Awards program, establishing submission deadlines and selecting the entry to Society programs.

Judging: A minimum of three judges will be selected by the <u>chair of the GAC Member Mobilization Subcommittee.GAC</u>. At least one judge should have experience as an <u>RVC of Government Affairs committee Chapter officer preferably with involvement in a Chapter government activity. Judging guidelines for the Society award are provided in the GAC's MOP. The judging occurs in the fall immediately following the last Chapters Regional Conference.</u>

## **REGION I 2019-20 GA MID-YEAR REPORT**

## Mid-Year Highlights:

Nine of the fifteen GA Chapter Chairs attended the 2019-20 CRC training session

Ten of the fifteen GA Chapter Chairs completed the planning session (MBO's) with the RVC

Thirteen of the fifteen chapters have assigned GA Chairs

Five of the fifteen chapters have assigned GA Co-Chairs

(2) GA Award Applications submitted to Region, (1) selected and submitted to Society

Massachusetts held a Government Outreach Day on December 10<sup>th</sup> in Boston. 2 chapter members attended this event and visited 2 legislatures.

New Jersey held a Government Outreach Day on December 16<sup>th</sup> in Trenton. This was a joint effort between Regions I and III with 7 chapter members who visited 6 legislatures.

The DEC and NYSERDA has released an HFC phase down following the EPA SNAP Regulations for chillers only. The New York Chapter headed by Thomas Reyes is working with DEC, NYSERDA, AHRI and UL to create language for the HFC phase down for unitary products.

The "New York State Climate Leadership and Community Protection Act" was signed into Law in July 2019, and includes aggressive carbon reduction target, as well as many other provisions of relevance to ASHRAE. The law also establishes Advisory panels that are to provide recommendations to the "New York State Climate Council". The Advisory panel is currently working on 4 buckets

- 1. Beneficial Electrification
- 2. Timeline for Refrigerant Phase out
- 3. Environmental Regulations
- 4. Safety Training and Workforce Development

The NY Chapter is also working with NYSERDA to offer a 6 month HVAC training and certification program through Universities and Community Schools. They are working with Pub Ed to offer 3 tracks for Engineers, Contractors and High School Students.

The Central New York Chapter is working with NYSERDA to create courses for NYSERDA to use for Workforce Development and training. The latest RFQ to be released is for Clean Energy Training Services. Mark Owen (Director of Publications and Education) along with his team are working on responding to this RFQ, which should open the door to more training, education and certification opportunities for ASHRAE. The chapter is also on the NYSERDA Advisory Committee for the 2020 Buildings of Excellence Competition. The competition will recognize persons whose projects stimulate the design, construction and operation of very low or zero carbon emitting buildings.

The Long Island Chapter is working with NYSERDA and PSEG (local power authority) to implement the use of BEQ in High Performance Building Evaluation. This has been a slow process with Bill Artis preparing reports and PSEG not seeing much value in spending \$300 in them. The chapter is also looking to see if a BEQ plaque can be made up for clients so they can see more benefit in the use of the program.

Bill Artis the head of the NY BEQ steering committee will work with NY GA Chairs and assign goals for each chapter to aid in promoting BEQ.







I was scheduled to visit the Puget Sound Chapter on January 16<sup>th</sup> 2020 and due to freezing conditions and snow, the visit has been postponed to a future date.

#### **PAOE Reporting:**

To date the only GA Chair that has reported PAOE Points to me directly is Gary Heikkinen from the Oregon Chapter 250 Points. The BC Chapter has reported 1000 points and the V.I Chapter has reported 650 points

Before Christmas I reached out to all my Chapter Chairs via Email in regards to PAOE reporting with a step by step narrative on how to navigate the PAOE Portal and enter their activities, with an offer of assistance at their convenience. #### 1.Building EQ Engagement

- 1. Bruce Lindsay and John Constantinide continue to engage Brevard Public Schools to utilize Building EQ for completing ASHRAE Standard 211-compliant Level 1 Energy Audits for its schools.
  - 1. A Joint Chapter-FIT Student Branch seminar presented the results of a three-school Building EQ Pilot Program.
  - 2. The next set of schools in the BPS Building EQ program will focus on high schools.
- 2. John Constantinide worked with Ian Lahiff, Jeff Benavides, and Nate Boyd, Central Florida Chapter GAC, to present a Building EQ seminar to the City of Orlando, Orlando Utility Commission, and other commercial stakeholders. This seminar was hosted with USGBC Central Florida.
  - 1. Note: Ian Lahiff works for the City of Orlando and is engaging with the Chris Castro, who works in the Mayor's office for the City's Green Works Orlando program.
  - 2. Jeff Benavides just was hired by Orange County to be their Sustainability and Resiliency Officer. He will continue working with us on promoting Building EQ to the City, and possibly the County.
- 3. Bruce Lindsay and John Constantinide engage the City of Melbourne's Beautification and Energy Efficiency Board (BEEB) about utilizing Building EQ to assist in completing ASHRAE Standard 211-compliant Level 1 Energy Audits, along with other energy strategies, using Brevard Public Schools' pilot program as a model.

#### 2. Energy Efficiency Strategies

- 1. Bruce Lindsay is working as a member of the City of Melbourne's BEEB to present an energy efficiency strategy for the City. John Constantinide assisted with drafting documentation and strategies. ASHRAE Standards 62.1, 90.1, and 211 were highlighted in the recommended strategies.
- 2. In collaboration with USGBC Brevard County, John Constantinide is working with Zach Eichholz, Sustainability Analyst with the City of Cape Canaveral to develop implementation of energy efficiency and resiliency measures. The City is also constructing and renovating buildings to be LEED Silver-certifiable, which comply with ASHRAE Standard 90.1 per LEED v4.0.
- 3. In collaboration with USGBC Brevard County, John Constantinide is working with Nick Sanzone, Sustainability Officer with the City of Satellite Beach, on more effective outreach to City residents on adopting residential energy efficiency measures.

#### **3.Government Participation**

- 1. Bruce Lindsay was appointed to the City of Melbourne's BEEB.
- 2. Bruce Lindsay and John Constantinide are being considered as appointees to the Brevard County Workgroup for Innovative Solar Energy Resources (WISER).





During the Members Council June 2019 meeting in Kansas City, the motions below were referred to the Government Affairs Committee (GAC) for consideration. Below are responses from the GAC that were considered by the GAC Executive Subcommittee on November 13, 2019 and by the full committee on February 1, 2020.

#### **Region XI (Oregon Chapter) – Motion 24 (06/25/2019):**

That Society Government Affairs Office write a letter urging the US President to submit the Kigali Amendment to the Montreal Protocol to the US Senate for ratification.

Background: See CRC Motion 8 (Motion 25 below), for background content.

Fiscal Impact: Unknown.

#### **GAC Response:**

The Government Affairs Committee (GAC) reviewed this request and was not in favor of the motion. The GAC considered this motion, and found it to be too political and U.S.-centric. The GAC has been charged with establishing ASHRAE as a "leading source for expertise in the built environment and a resource for policy-makers in the development of legislation and regulations affecting the public, the HVAC&R community, and the engineering profession." There is no charge to the GAC or to ASHRAE to provide strategic or political guidance to policy makers or elected officials. The GAC will continue to monitor whether the Kigali amendment is advanced to the U.S. Senate for its advice and consent.

#### Region XI (Oregon Chapter – Motion 25 (06/25/2019):

That Society add "Advocate phaseout of HFC refrigerants in the United States" to the 2019-2020 Public priorities list.

Background: Finalized in 1987 and ratified by the United States and Canada in 1988, the Montreal Protocol was an international agreement that phased out the use of ozone-depleting substances, including many common refrigerants. The most common class of replacement refrigerants are known as HFCs (hydrofluorocarbons), and are among the most commonly used refrigerants to date. HFCs are not ozone-depleting substances, but in recent years have been identified as significant greenhouse gases, with global warming potential (GWP) from 140 to 11,700 times that of carbon dioxide (over a 100-year lifespan).

In 2016, the Kigali Amendment to the Montreal Protocol aimed to use the framework of the existing Protocol to regulate and eliminate HFCs from global use. In the face of global temperature rises of over 2C, the international community recognized that HFC phase out could be the single most effective action



the world could take to reduce the impacts of global climate change.

Fifty three countries have ratified the Kigali Amendment to date, including Canada. The phaseout timeline of the Amendment began in January of 2019, and countries who have ratified are beginning to phase HFCs out of use.

The United States has not yet ratified the Amendment. The United States participated in the Summit, and the EPA appeared poised to regulate HFCs, issuing a 2016 rule after the Kigali summit that would have extended the EPA's authority over certain air pollutants to include HFCs (allowing regulation of leakage and refrigerant management). However, in 2018, judges ruled that the EPA had overstepped its bounds in using the Clean Air Act to regulate HFCs, and the future of HFC regulation and phaseout in the US is uncertain.

## ASHRAE has previously written position papers and provided commentary in support of responsible refrigerant management.<sup>1</sup>

In 2018, the EPA proposed revisions to Clean Air Act rules that would have required refrigerant management for only ozone-depleting refrigerants (not HFCs). In November of 2018, ASHRAE provided comments indicating support for regulatory management of all refrigerants (including HFCs) and urging the EPA to reconsider the proposed action.<sup>2</sup>

In ASHRAE's 2018 position document on refrigerants, ASHRAE recommended the following efforts for governmental and nongovernmental institutions:

- "Develop relevant measures that promote the use of lower total system GWP (refrigerant charge multiplied by the GWP of the refrigerant) and energy-efficient HVAC&R systems.
- Introduce procedures and guidelines, working with the United Nations Environmental Programme (UNEP) and other organizations and regulatory bodies, to enable sustainable procurement policies that promote the deployment of lower total system GWP refrigerants and their responsible use while commissioning, operating, and servicing HVAC&R systems.<sup>3</sup>"

In June of 2018, ASHRAE published the "ASHRAE Position Document on Climate Change" that outlined ASHRAE's position and recommendations. The position document states:

"ASHRAE holds the following strong positions:

- Climate change is the most formidable environmental challenge ever faced by society.....
- ASHRAE members and staff should become actively involved worldwide with policy-setting entities to encourage sound, balanced, and innovative actions to address long-range environmental problems and the conditions that result from them."<sup>4</sup>

ASHRAE actively supports the research of alternative refrigerants to HFCs, including mildly flammable refrigerants that are a direct substitute for high-GWP HFC refrigerants.

HFC phaseout is an important step to reducing the impact of global climate change.

Recent studies indicate that global HFC phase out could result in avoided 0.5C of warming.<sup>5</sup> This action alone could be the "largest temperature reduction ever achieved by a single agreement."<sup>6</sup>

These actions are in line with ASHRAE's mission, and ASHRAE members and constituents are in favor of HFC phase out.

ASHRAE members and volunteers are in support of HFC phase out. A coalition of 32 HVAC company executives submitted a letter in May of 2018 urging the President of the US to submit the Kigali Amendment to the US Senate for ratification.<sup>7</sup>

Fiscal Impact: Unknown.

#### **GAC Response:**

The Government Affairs Committee (GAC) reviewed this request and was not in favor of the motion. The Public Policy Priorities for 2019-2020 were already approved by the Board of Directors at the 2019 Annual Meeting in Kansas City, so they are finalized. In addition, the GAC wanted the region to be aware that the approach of the Kigali Amendment is to *phase down* HFCs over time rather than to phase them out. Further, high-GWP HFCs are targeted, rather than all HFCs. Finally, ASHRAE is a global society, and we should not focus only on the U.S.

The GAC thanks Region X and the Oregon Chapter for considering this important policy matter. The GAC will consider including in its 2020-2021 Public Policy Priorities a statement on refrigerants, which will be derived from the positions in the ASHRAE June 2018 Position Document titled, "Refrigerants and their Responsible Use," which are listed below:

Selection of refrigerants and their systems must be based on a holistic analysis including energy
efficiency and performance attributes, environmental impacts, employee and public safety, and
economic considerations. A refrigerant should not be selected based on any one single factor
such as GWP, operating pressure, flammability, etc. The wide range of HVAC&R applications and
their requirements throughout the world necessitates a variety of refrigerants to meet these
needs.

- To limit direct and indirect impacts on the environment, emissions of refrigerants should be reduced through research, education, improved design, manufacturing/construction of equipment, field commissioning, maintenance procedures, decommissioning, and enforcement of applicable standards and regulations.
- Where possible, refrigerants should be safely recovered for reuse, recycle, reclamation, or
  destruction during service or at the end of the life of the equipment. Refrigerant inventory and
  management programs should be implemented to closely track refrigerant use.
- ASHRAE encourages and supports ongoing efforts to develop new refrigerants and improve the application of existing refrigerants to meet these criteria.

During the Members Council November 2019 meeting in Atlanta, the council referred the motion below (Motion 7c) to each of the Grassroots Committees for review to determine what works best for them and if their specific ROB should be updated as suggested in the motion. Below is the response from the GAC, which was considered by the full committee on February 1, 2020.

#### Region IX (Kansas City Chapter) Motion 7c (11/14/2019):

That the candidate requirements for all Regional Vice Chair positions be revised except for the YEA Regional Vice Chair as follows:

"Regional Vice Chairs shall hold Member grade or higher in the Society, shall have been in the grade of Member and in good standing for three years prior to the start of their terms....."

**Background:** This motion standardizes all RVC position qualification requirements and allows the best leader to be nominated regardless of age.

Current RVC candidate requirements require you to have a Member Grade for 3 years before being eligible for nomination. That means the earliest you could be eligible to be nominated for an RVC position is 7 years out of college because the earliest you can become a Member is a minimum of 4 years after college (12 total points or years are needed with 4 points for graduating from an accredited school, 4 points for a PE, and one (1) point for each year in the industry after you receive your PE). This assumes that individual gets their PE as soon as they are eligible out of school. There is a common trend of burnout of ASHRAE volunteers. Once people complete their local chapter's board of governors chairs, many are burned out from the volunteer time commitment to ASHRAE and they lose interest in taking on positions at the Regional level. By the time people are eligible to apply to be an RVC, timing isn't ideal because people aged in their early 30's are getting busier with their careers and family life resulting in less time available to volunteer/travel. Making requirements for RVC nominations less stringent in terms of age/experience will lead to more candidate nominations, will reduce the need to get exceptions/variances for people who are nominated who don't meet the requirements, will encourage younger candidates to get involved at a Regional level, and will help better diversify ASHRAE Society.

It is a common occurrence that exceptions are taken to the qualification requirement, this motion would reduce/eliminate the need for exceptions.

What if people are concerned that reducing the requirements (age/years in the industry) will lead to unqualified nominees? The nominating process requires candidates nominated to be qualified individuals. Delegates and alternates are aware of requirements of each RVC position and are dedicated to only nominating candidates who would be a good fit for the job.



# **ASHRAE Commercialism Policy**

ASHRAE's Commercialism Policy allows for Society activities that fulfill the mission of technological advancement with adherence to business plans that generate income to offset operational expenses such as AHR Exposition, ASHRAE periodicals, website, and Society conference events such as the Welcome Party, luncheons, registration kits, and receptions.

### **Principles for Managing Advertising and Sponsorships**

- Content should be labeled as advertising or sponsored.
- Use of commercial names and logos shall not imply ASHRAE endorsement, approval or certification of products or services.
- The inclusion of commercial information shall be fair and unbiased so as to avoid explicit promotion of a product or commercial entity.
- Content shall adhere to accepted business practices specified by the U.S. Federal Trade Commission and recognized publishing authorities.
- Activities including events at chapter meetings shall be managed to prevent an atmosphere in which commercial entities are encouraged to critique one another in the public forum.



# **Proposed Bylaw Change**

PROPOSED

BYLAW

CHANGES

The proposed changes are noted in red text below.

**Section 3.3 Voting**. At any annual, winter, or special meeting, each voting member, as defined in Section 2.11, shall be entitled to one vote, which may be cast in person or by proxy. A proxy shall not be valid longer than three months from its date of execution.

Nominations shall be put forward by the Nominating Committee as hereinafter provided in Section 7.6.

Nominations may also be made in writing by <u>petition signed by not fewer than ½ of 1% of the fifty</u> members eligible to vote. <u>No more than 50% of the petitioners belonging to any single region shall count towards the required minimum. The minimum number of members eligible to vote shall be <u>based on the Society's membership roster as of the first day of the Society year.</u> Upon presentation of such nominations <u>by petition</u> to the Secretary with each nominee's written consent, not less than one hundred twenty days prior to the first session of the annual meeting, the nominees' names shall be placed upon the ballot. A notation on the ballot shall indicate that such nominees are presented by members independent of the Nominating Committee.</u>



### Report from Building EQ Committee to Government Affairs Committee Orlando Winter Meeting – February 2020

- Building EQ continues to align the Building EQ Portal with other ASHRAE resources to improve the benefit
  of the tool to ASHRAE members. The alignment efforts include Standard 211-2018 (Standard for
  Commercial Building Energy Audits), Standard 100-2018 (Energy Efficiency in Existing Buildings), and the
  Performance Measurement Protocols books.
- 2. A government oriented PowerPoint presentation was completed and distributed to the appropriate GAC subcommittee for feedback and approval. It provides an overview of the Portal with a focus on how it benefits jurisdictions and municipalities.

#### Report from Residential Building Committee to Government Affairs Committee Orlando Winter Meeting – February 2020

#### **INFORMATION ITEMS:**

- The Residential Building committee (RBC) is in the process of reaching out to residential stakeholders and organizations that are not traditionally ASHRAE members in order to identify critical needs and opportunities for collaboration and growth in the residential sector.
- RBC has compiled a list of residential themed conferences. RESNET was identified as a high priority for ASHRAE involvement and a free booth has been secured for their February 2020 conference. The outcome of this event will be evaluated for consideration of future ASHRAE involvement in other similar residential conferences.
- 3. RBC is reviewing past and present residential themed research projects at ASHRAE in an effort to develop processes for identifying, supporting, and promoting research for residential buildings and systems.
- 4. RBC continues to provide support and input to TC 2.1 and TC 7.6 in the development of WS 1861 Thermal Comfort in U.S. and Canadian residences: indoor conditions, occupant behavior and energy consumption.
- 5. RBC continues to support efforts to add residential themed sessions to the Technical Program at ASHRAE Winter and Annual meetings.
- 6. RBC continues to support efforts to submit quarterly residential themed column articles in the ASHRAE Journal.
- 7. The RBC sponsored Multifamily Design Guide (RP-1821) will be published this year.
- 8. RBC is exploring how to make residential content in the Handbooks more identifiable.
- 9. RBC is exploring development of a liaison system for technical and standard committees applicable to residential buildings.
