August 23, 2024 to September 22, 2024**

- ♦ **1st Public Review of BSR/ASHRAE/ASHE Addendum I to ANSI/ASHRAE/ASHE Standard 189.3-2021, *Design, Construction, and Operation of Sustainable High-Performance Health Care Facilities***

This addendum updates the lighting power densities with special consideration for healthcare areas. Table 7.4.6.1 B and C are updated to reflect these changes along with updated foot notes for the user to follow the table. The values in the tables are from a study which encompassed ten distinct healthcare facilities, ranging from medical office buildings to acute care centers, children's hospitals, cancer centers and birthing centers, situated across California, Hawaii, Tennessee, Georgia, and Oregon. Projects varied in size from 20,000 square feet to several hundred thousand square feet, representing recent projects. By averaging LPDs across these facilities, the studio conducted comparisons against prevailing energy codes such as Title24, IECC, ASHRAE 90.1, and 189.1. This rigorous evaluation yielded detailed insights into current industry standards and the results informed the LPD values listed in this addendum.

- ♦ **1st Public Review of BSR/ASHRAE/ACCA Addendum a to ANSI/ASHRAE/ACCA Standard 211-2018 (RA 2023), *Standard for Commercial Building Energy Audits***

This addendum reflects changes to Standard 211's Title, Purpose, and Scope (TPS) approved by ASHRAE in June 2024. The new TPS will enable Standard 211 to provide guidance on performing a decarbonization assessment in conjunction with an energy audit.

- ♦ **1st BSR/ASHRAE Standard 222-2018R, *Standard Method of Test for Electrical Power Drive Systems***

This revision of ANSI/ASHRAE Standard 222-2018 determines the performance of power drive systems for rating the energy efficiency and electrical compatibility with the power supply systems and with motor insulation.
