#### <u>30-day Public Review from</u> September 20, 2024 to October 20, 2024

 2<sup>nd</sup> Public Review of BSR/ASHRAE/ICC/USGBC/ IES Addendum b to ANSI/ASHRAE/ICC/USGBC/ IES Standard 189.1-2023, Standard for the Design of High-Performance Green Buildings Except Low-Rise Residential Buildings, Independent Substantive Changes

This addendum creates a Jurisdictional Option (JO) that prohibits future installation of irrigation systems for nonfunctional turfgrass. Turfgrass is one of the highest water use plants commonly found in landscapes in the built environment. Communities in arid areas will be the most interested in this JO, though water shortages can occur for reasons other, such as water system treatment and distribution limitations or source water impairment. As such, this may be of interest to a significant set of AHJs. This second public review makes changes suggested during the first public review comment period and other committee members.
